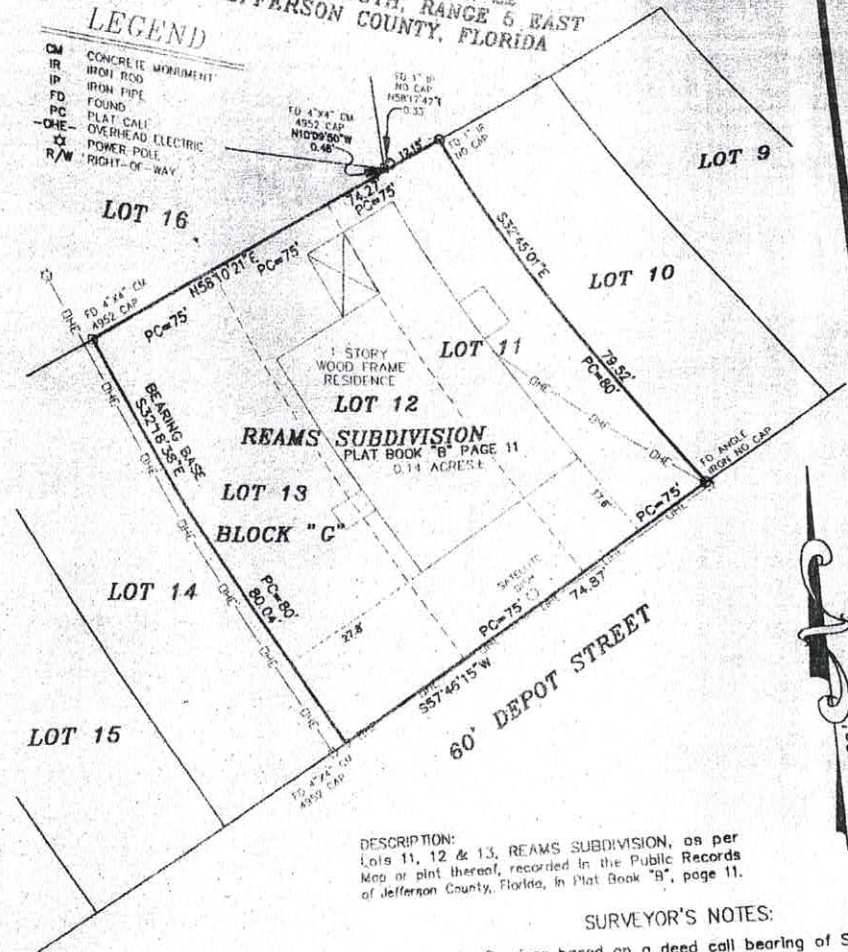


**A BOUNDARY SURVEY FOR ROBERT PERRY

**SURVEYOR'S NOTES:**

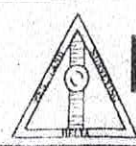
1. Bearings based on a deed call bearing of South 32 degrees 18 minutes 38 seconds East along a tie to the Southerly boundary of the Subject property.

4. Field work was completed September 19, 2003.
