188 **3.2. Applicability of Terms.** If any deadline blank in § 3.1. (Dates and Deadlines) is left blank or  
 189 completed with "N/A", or the word "Deleted," such deadline is not applicable and the corresponding provision  
 190 containing the deadline is deleted. Any box checked in this Contract means the corresponding provision  
 191 applies. If no box is checked in a provision that contains a selection of "None", such provision means that  
 192 "None" applies.  
 193

194 The abbreviation "MEC" (mutual execution of this Contract) means the date upon which both parties have  
 195 signed this Contract. The abbreviation "N/A" as used in this Contract means not applicable.  
 196

197 **3.3. Day; Computation of Period of Days; Deadlines.**

198 **3.3.1. Day.** As used in this Contract, the term "day" means the entire day ending at 11:59 p.m.,  
 199 United States Mountain Time (Standard or Daylight Savings, as applicable). Except however, if a **Time of**  
 200 **Day Deadline** is specified in § 3.1. (Dates and Deadlines), all Objection Deadlines, Resolution Deadlines,  
 201 Examination Deadlines and Termination Deadlines will end on the specified deadline date at the time of day  
 202 specified in the **Time of Day Deadline**, United States Mountain Time. If **Time of Day Deadline** is left blank  
 203 or "N/A" the deadlines will expire at 11:59 p.m., United States Mountain Time.  
 204

205 **3.3.2. Computation of Period of Days.** In computing a period of days (e.g., three days after  
 206 MEC), when the ending date is not specified, the first day is excluded and the last day is included.

207 **3.3.3. Deadlines.** If any deadline falls on a Saturday, Sunday or federal or Colorado state holiday  
 208 (Holiday), such deadline  **Will**  **Will Not** be extended to the next day that is not a Saturday, Sunday or  
 209 Holiday. Should neither box be checked, the deadline will not be extended.

226 **4.2. Seller Concession.** At Closing, Seller will credit to Buyer \$**N/A** (Seller Concession). The Seller  
 227 Concession may be used for any Buyer fee, cost, charge or expenditure to the extent the amount is allowed  
 228

233 by the Buyer's lender and is included in the Closing Statement or Closing Disclosure at Closing. Examples of  
234 allowable items to be paid for by the Seller Concession include, but are not limited to: Buyer's closing costs,  
235 loan discount points, loan origination fees, prepaid items and any other fee, cost, charge, expense or  
236 expenditure. Seller Concession is in addition to any sum Seller has agreed to pay or credit Buyer elsewhere  
237 in this Contract.  
238

239 **4.3. Earnest Money.** The Earnest Money set forth in this Section, in the form of a **Good Funds**, will  
240 be payable to and held by **Fidelity National Title** (Earnest Money Holder), in its trust account, on behalf of  
241 both Seller and Buyer. The Earnest Money deposit must be tendered, by Buyer, with this Contract unless the  
242 parties mutually agree to an **Alternative Earnest Money Deadline** for its payment. The parties authorize  
243 delivery of the Earnest Money deposit to the company conducting the Closing (Closing Company), if any, at  
244 or before Closing. In the event Earnest Money Holder has agreed to have interest on Earnest Money  
245 deposits transferred to a fund established for the purpose of providing affordable housing to Colorado  
246 residents, Seller and Buyer acknowledge and agree that any interest accruing on the Earnest Money  
247 deposited with the Earnest Money Holder in this transaction will be transferred to such fund.  
248

249 **4.3.1. Alternative Earnest Money Deadline.** The deadline for delivering the Earnest Money, if  
250 other than at the time of tender of this Contract, is as set forth as the **Alternative Earnest Money Deadline**.

251 **4.3.2. Disposition of Earnest Money.** If Buyer has a Right to Terminate and timely terminates,  
252 Buyer is entitled to the return of Earnest Money as provided in this Contract. If this Contract is terminated as  
253 set forth in § 24 and, except as provided in § 23 (Earnest Money Dispute), if the Earnest Money has not  
254 already been returned following receipt of a Notice to Terminate, Seller agrees to execute and return to Buyer  
255 or Broker working with Buyer, written mutual instructions (e.g., Earnest Money Release form), within three  
256 days of Seller's receipt of such form. If Seller is entitled to the Earnest Money, and, except as provided in §  
257 23 (Earnest Money Dispute), if the Earnest Money has not already been paid to Seller, following receipt of an  
258 Earnest Money Release form, Buyer agrees to execute and return to Seller or Broker working with Seller,  
259 written mutual instructions (e.g., Earnest Money Release form), within three days of Buyer's receipt.  
260

261 **4.3.2.1. Seller Failure to Timely Return Earnest Money.** If Seller fails to timely execute  
262 and return the Earnest Money Release Form, or other written mutual instructions, Seller is in default and  
263 liable to Buyer as set forth in "If Seller is in Default", § 20.2. and § 21, unless Seller is entitled to the  
264 Earnest Money due to a Buyer default.  
265

266 **4.3.2.2. Buyer Failure to Timely Release Earnest Money.** If Buyer fails to timely execute  
267 and return the Earnest Money Release Form, or other written mutual instructions, Buyer is in default and  
268 liable to Seller as set forth in "If Buyer is in Default, § 20.1. and § 21, unless Buyer is entitled to the Earnest  
269 Money due to a Seller Default.  
270

#### 270 **4.4. Form of Funds; Time of Payment; Available Funds.**

271 **4.4.1. Good Funds.** All amounts payable by the parties at Closing, including any loan proceeds,  
272 Cash at Closing and closing costs, must be in funds that comply with all applicable Colorado laws, including  
273 electronic transfer funds, certified check, savings and loan teller's check and cashier's check (Good Funds).  
274

275 **4.4.2. Time of Payment.** All funds, including the Purchase Price to be paid by Buyer, must be  
276 paid before or at Closing or as otherwise agreed in writing between the parties to allow disbursement by  
277 Closing Company at Closing **OR SUCH NONPAYING PARTY WILL BE IN DEFAULT.**

278 **4.4.3. Available Funds.** Buyer represents that Buyer, as of the date of this Contract,  **Does**  
279  **Does Not** have funds that are immediately verifiable and available in an amount not less than the amount  
280 stated as Cash at Closing in § 4.1.  
281

#### 281 **4.5. New Loan.**

282 **4.5.1. Buyer to Pay Loan Costs.** Buyer, except as otherwise permitted in § 4.2. (Seller  
283 Concession), if applicable, must timely pay Buyer's loan costs, loan discount points, prepaid items and loan  
284 origination fees as required by lender.  
285

286 **4.5.2. Buyer May Select Financing.** Buyer may pay in cash or select financing appropriate and  
287 acceptable to Buyer, including a different loan than initially sought, except as restricted in § 4.5.3. (Loan  
288 Limitations) or § 29 (Additional Provisions).

290 **4.5.3. Loan Limitations.** Buyer may purchase the Property using any of the following types of

297

298 **5. FINANCING CONDITIONS AND OBLIGATIONS.**

299 **5.1. New Loan Application.** If Buyer is to pay all or part of the Purchase Price by obtaining one or  
300 more new loans (New Loan), or if an existing loan is not to be released at Closing, Buyer, if required by such  
301 lender, must make an application verifiable by such lender, on or before **New Loan Application Deadline**  
302 and exercise reasonable efforts to obtain such loan or approval.  
303

304 **5.2. New Loan Terms; New Loan Availability.**

305 **5.2.1. New Loan Terms.** If Buyer is to pay all or part of the Purchase Price with a New Loan, this  
306 Contract is conditional upon Buyer determining, in Buyer's sole subjective discretion, whether the proposed  
307 New Loan's payments, interest rate, conditions and costs or any other loan terms (New Loan Terms) are  
308 satisfactory to Buyer. This condition is for the sole benefit of Buyer. Buyer has the Right to Terminate under §  
309 24.1., on or before **New Loan Terms Deadline**, if the New Loan Terms are not satisfactory to Buyer, in  
310 Buyer's sole subjective discretion.  
311

312 **5.2.2. New Loan Availability.** If Buyer is to pay all or part of the Purchase Price with a New  
313 Loan, this Contract is conditional upon Buyer's satisfaction with the availability of the New Loan based on the  
314 lender's review and underwriting of Buyer's New Loan Application (New Loan Availability). Buyer has the  
315 Right to Terminate under § 24.1., on or before the **New Loan Availability Deadline** if the New Loan  
316 Availability is not satisfactory to Buyer. Buyer does not have a Right to Terminate based on the New Loan  
317 Availability if the termination is based on the New Loan Terms, Appraised Value (defined below), the Lender  
318 Property Requirements (defined below), Insurability (§ 10.5. below) or the Conditional Upon Sale of Property  
319 (§ 10.7. below). **IF SELLER IS NOT IN DEFAULT AND DOES NOT TIMELY RECEIVE BUYER'S WRITTEN**  
320 **NOTICE TO TERMINATE, BUYER'S EARNEST MONEY WILL BE NONREFUNDABLE**, except as  
321 otherwise provided in this Contract (e.g., Appraisal, Title, Survey).  
322

323 **5.3. Credit Information.** (Omitted as inapplicable)

324 **5.4. Existing Loan Review.** (Omitted as inapplicable)  
325

326 **6. APPRAISAL PROVISIONS.**

327 **6.1. Appraisal Definition.** An "Appraisal" is an opinion of value prepared by a licensed or certified  
328 appraiser, engaged on behalf of Buyer or Buyer's lender, to determine the Property's market value (Appraised  
329 Value). The Appraisal may also set forth certain lender requirements, replacements, removals or repairs  
330 necessary on or to the Property as a condition for the Property to be valued at the Appraised Value.  
331

332 **6.2. Appraised Value.** The applicable appraisal provision set forth below applies to the respective  
333 loan type set forth in § 4.5.3., or if a cash transaction (i.e., no financing), § 6.2.1. applies.

334 **6.2.1. Conventional/Other.** Buyer has the right to obtain an Appraisal. If the Appraised Value is  
335 less than the Purchase Price, or if the Appraisal is not received by Buyer on or before **Appraisal Deadline**  
336 Buyer may, on or before **Appraisal Objection Deadline**:

337 **6.2.1.1. Notice to Terminate.** Notify Seller in writing, pursuant to § 24.1., that this Contract  
338 is terminated; or  
339

340 **6.2.1.2. Appraisal Objection.** Deliver to Seller a written objection accompanied by either a  
341 copy of the Appraisal or written notice from lender that confirms the Appraised Value is less than the  
342 Purchase Price (Lender Verification).  
343

344 **6.2.1.3. Appraisal Resolution.** If an Appraisal Objection is received by Seller, on or before  
345 **Appraisal Objection Deadline** and if Buyer and Seller have not agreed in writing to a settlement thereof on  
346 or before **Appraisal Resolution Deadline**, this Contract will terminate on the **Appraisal Resolution**  
347 **Deadline**, unless Seller receives Buyer's written withdrawal of the Appraisal Objection before such  
348 termination, (i.e., on or before expiration of **Appraisal Resolution Deadline**).  
349

350 **6.3. Lender Property Requirements.** If the lender imposes any written requirements, replacements,  
351 removals or repairs, including any specified in the Appraisal (Lender Property Requirements) to be made to  
352 the Property (e.g., roof repair, repainting), beyond those matters already agreed to by Seller in this Contract,  
353 this Contract terminates on the earlier of three days following Seller's receipt of the Lender Property  
354 Requirements, or Closing, unless prior to termination: (1) the parties enter into a written agreement to satisfy  
355 the Lender Property Requirements; (2) the Lender Property Requirements have been completed; or (3) the  
356 satisfaction of the Lender Property Requirements is waived in writing by Buyer.  
357

358 **6.4. Cost of Appraisal.** Cost of the Appraisal to be obtained after the date of this Contract must be  
359 timely paid by  Buyer  Seller. The cost of the Appraisal may include any and all fees paid to the  
360 appraiser, appraisal management company, lender's agent or all three.  
361

362 **7. OWNERS' ASSOCIATIONS.** This Section is applicable if the Property is located within one or more  
363 Common Interest Communities and subject to one or more declarations (Association).  
364

365 **7.1. Common Interest Community Disclosure. THE PROPERTY IS LOCATED WITHIN A**  
366 **COMMON INTEREST COMMUNITY AND IS SUBJECT TO THE DECLARATION FOR THE COMMUNITY.**  
367 **THE OWNER OF THE PROPERTY WILL BE REQUIRED TO BE A MEMBER OF THE OWNERS'**  
368 **ASSOCIATION FOR THE COMMUNITY AND WILL BE SUBJECT TO THE BYLAWS AND RULES AND**  
369 **REGULATIONS OF THE ASSOCIATION. THE DECLARATION, BYLAWS AND RULES AND**  
370 **REGULATIONS WILL IMPOSE FINANCIAL OBLIGATIONS UPON THE OWNER OF THE PROPERTY,**  
371 **INCLUDING AN OBLIGATION TO PAY ASSESSMENTS OF THE ASSOCIATION. IF THE OWNER DOES**  
372 **NOT PAY THESE ASSESSMENTS, THE ASSOCIATION COULD PLACE A LIEN ON THE PROPERTY**  
373 **AND POSSIBLY SELL IT TO PAY THE DEBT. THE DECLARATION, BYLAWS AND RULES AND**  
374 **REGULATIONS OF THE COMMUNITY MAY PROHIBIT THE OWNER FROM MAKING CHANGES TO THE**  
375 **PROPERTY WITHOUT AN ARCHITECTURAL REVIEW BY THE ASSOCIATION (OR A COMMITTEE OF**  
376 **THE ASSOCIATION) AND THE APPROVAL OF THE ASSOCIATION. PURCHASERS OF PROPERTY**  
377 **WITHIN THE COMMON INTEREST COMMUNITY SHOULD INVESTIGATE THE FINANCIAL**  
378 **OBLIGATIONS OF MEMBERS OF THE ASSOCIATION. PURCHASERS SHOULD CAREFULLY READ**  
379 **THE DECLARATION FOR THE COMMUNITY AND THE BYLAWS AND RULES AND REGULATIONS OF**  
380 **THE ASSOCIATION.**  
381

382 **7.2. Association Documents to Buyer.** Seller is obligated to provide to Buyer the Association  
383 Documents (defined below), at Seller's expense, on or before **Association Documents Deadline.** Seller  
384 authorizes the Association to provide the Association Documents to Buyer, at Seller's expense. Seller's  
385 obligation to provide the Association Documents is fulfilled upon Buyer's receipt of the Association  
386 Documents, regardless of who provides such documents.  
387

388 **7.3. Association Documents.** Association documents (Association Documents) consist of the  
389 following:

390 **7.3.1.** All Association declarations, articles of incorporation, bylaws, articles of organization,  
391 operating agreements, rules and regulations, party wall agreements and the Association's responsible  
392 governance policies adopted under § 38-33.3-209.5, C.R.S.;

393 **7.3.2.** Minutes of: (1) the annual owners' or members' meeting and (2) any executive boards' or  
394 managers' meetings; such minutes include those provided under the most current annual disclosure required  
395 under § 38-33.3-209.4, C.R.S. (Annual Disclosure) and minutes of meetings, if any, subsequent to the  
396 minutes disclosed in the Annual Disclosure. If none of the preceding minutes exist, then the most recent  
397 minutes, if any (§§ 7.3.1. and 7.3.2., collectively, Governing Documents); and

398 **7.3.3.** List of all Association insurance policies as provided in the Association's last Annual  
399 Disclosure, including, but not limited to, property, general liability, association director and officer professional  
400 liability and fidelity policies. The list must include the company names, policy limits, policy deductibles,  
401 additional named insureds and expiration dates of the policies listed (Association Insurance Documents);

402 **7.3.4.** A list by unit type of the Association's assessments, including both regular and special  
403 assessments as disclosed in the Association's last Annual Disclosure;

404 **7.3.5.** The Association's most recent financial documents which consist of: (1) the Association's  
405 operating budget for the current fiscal year, (2) the Association's most recent annual financial statements,  
406  
407

408 including any amounts held in reserve for the fiscal year immediately preceding the Association's last Annual  
409 Disclosure, (3) the results of the Association's most recent available financial audit or review, (4) list of the  
410 fees and charges (regardless of name or title of such fees or charges) that the Association's community  
411 association manager or Association will charge in connection with the Closing including, but not limited to,  
412 any fee incident to the issuance of the Association's statement of assessments (Status Letter), any rush or  
413 update fee charged for the Status Letter, any record change fee or ownership record transfer fees (Record  
414 Change Fee), fees to access documents, (5) list of all assessments required to be paid in advance, reserves  
415 or working capital due at Closing and (6) reserve study, if any (§§ 7.3.4. and 7.3.5., collectively, Financial  
416 Documents);

417  
418 **7.3.6.** Any written notice from the Association to Seller of a "construction defect action" under §  
419 38-33.3-303.5, C.R.S. within the past six months and the result of whether the Association approved or  
420 disapproved such action (Construction Defect Documents). Nothing in this Section limits the Seller's  
421 obligation to disclose adverse material facts as required under § 10.2. (Disclosure of Adverse Material Facts;  
422 Subsequent Disclosure; Present Condition) including any problems or defects in the common elements or  
423 limited common elements of the Association property.  
424

425 **7.4. Conditional on Buyer's Review.** Buyer has the right to review the Association Documents.  
426 Buyer has the Right to Terminate under § 24.1., on or before **Association Documents Termination**  
427 **Deadline**, based on any unsatisfactory provision in any of the Association Documents, in Buyer's sole  
428 subjective discretion. Should Buyer receive the Association Documents after **Association Documents**  
429 **Deadline**, Buyer, at Buyer's option, has the Right to Terminate under § 24.1. by Buyer's Notice to Terminate  
430 received by Seller on or before ten days after Buyer's receipt of the Association Documents. If Buyer does  
431 not receive the Association Documents, or if Buyer's Notice to Terminate would otherwise be required to be  
432 received by Seller after **Closing Date**, Buyer's Notice to Terminate must be received by Seller on or before  
433 Closing. If Seller does not receive Buyer's Notice to Terminate within such time, Buyer accepts the provisions  
434 of the Association Documents as satisfactory and Buyer waives any Right to Terminate under this provision,  
435 notwithstanding the provisions of § 8.6. (Third Party Right to Purchase/Approve).  
436

## 437 **8. TITLE INSURANCE, RECORD TITLE AND OFF-RECORD TITLE.**

### 438 **8.1. Evidence of Record Title.**

439  **8.1.1. Seller Selects Title Insurance Company.** If this box is checked, Seller will select the  
440 title insurance company to furnish the owner's title insurance policy at Seller's expense. On or before **Record**  
441 **Title Deadline**, Seller must furnish to Buyer, a current commitment for an owner's title insurance policy (Title  
442 Commitment), in an amount equal to the Purchase Price, or if this box is checked,  an **Abstract of Title**  
443 certified to a current date. Seller will cause the title insurance policy to be issued and delivered to Buyer as  
444 soon as practicable at or after Closing.  
445

446  **8.1.2. Buyer Selects Title Insurance Company.** If this box is checked, Buyer will select the  
447 title insurance company to furnish the owner's title insurance policy at Buyer's expense. On or before **Record**  
448 **Title Deadline**, Buyer must furnish to Seller, a current commitment for owner's title insurance policy (Title  
449 Commitment), in an amount equal to the Purchase Price.  
450

451 If neither box in § 8.1.1. or § 8.1.2. is checked, § 8.1.1. applies.

452 **8.1.3. Owner's Extended Coverage (OEC).** The Title Commitment  **Will**  **Will Not** contain  
453 Owner's Extended Coverage (OEC). If the Title Commitment is to contain OEC, it will commit to delete or  
454 insure over the standard exceptions which relate to: (1) parties in possession, (2) unrecorded easements, (3)  
455 survey matters, (4) unrecorded mechanics' liens, (5) gap period (period between the effective date and time  
456 of commitment to the date and time the deed is recorded) and (6) unpaid taxes, assessments and  
457 unredeemed tax sales prior to the year of Closing. Any additional premium expense to obtain OEC will be  
458 paid by  **Buyer**  **Seller**  **One-Half by Buyer and One-Half by Seller**  **Other** N/A.  
459

460 Regardless of whether the Contract requires OEC, the Title Insurance Commitment may not provide OEC or  
461 delete or insure over any or all of the standard exceptions for OEC. The Title Insurance Company may  
462 require a New Survey or New ILC, defined below, among other requirements for OEC. If the Title Insurance  
463 Commitment is not satisfactory to Buyer, Buyer has a right to object under § 8.7. (Right to Object to Title,  
464 Resolution).  
465



466 **8.1.4. Title Documents.** Title Documents consist of the following: (1) copies of any plats,  
467 declarations, covenants, conditions and restrictions burdening the Property and (2) copies of any other  
468 documents (or, if illegible, summaries of such documents) listed in the schedule of exceptions (Exceptions) in  
469 the Title Commitment furnished to Buyer (collectively, Title Documents).  
470

471 **8.1.5. Copies of Title Documents.** Buyer must receive, on or before **Record Title Deadline**,  
472 copies of all Title Documents. This requirement pertains only to documents as shown of record in the office of  
473 the clerk and recorder in the county where the Property is located. The cost of furnishing copies of the  
474 documents required in this Section will be at the expense of the party or parties obligated to pay for the  
475 owner's title insurance policy.  
476

477 **8.1.6. Existing Abstracts of Title.** Seller must deliver to Buyer copies of any abstracts of title  
478 covering all or any portion of the Property (Abstract of Title) in Seller's possession on or before **Record Title**  
479 **Deadline**.

480 **8.2. Record Title.** Buyer has the right to review and object to the Abstract of Title or Title Commitment  
481 and any of the Title Documents as set forth in § 8.7. (Right to Object to Title, Resolution) on or before  
482 **Record Title Objection Deadline**. Buyer's objection may be based on any unsatisfactory form or content of  
483 Title Commitment or Abstract of Title, notwithstanding § 13, or any other unsatisfactory title condition, in  
484 Buyer's sole subjective discretion. If the Abstract of Title, Title Commitment or Title Documents are not  
485 received by Buyer on or before the **Record Title Deadline**, or if there is an endorsement to the Title  
486 Commitment that adds a new Exception to title, a copy of the new Exception to title and the modified Title  
487 Commitment will be delivered to Buyer. Buyer has until the earlier of Closing or ten days after receipt of such  
488 documents by Buyer to review and object to: (1) any required Title Document not timely received by Buyer,  
489 (2) any change to the Abstract of Title, Title Commitment or Title Documents, or (3) any endorsement to the  
490 Title Commitment. If Seller receives Buyer's Notice to Terminate or Notice of Title Objection, pursuant to this  
491 § 8.2. (Record Title), any title objection by Buyer is governed by the provisions set forth in § 8.7. (Right to  
492 Object to Title, Resolution). If Seller has fulfilled all Seller's obligations, if any, to deliver to Buyer all  
493 documents required by § 8.1. (Evidence of Record Title) and Seller does not receive Buyer's Notice to  
494 Terminate or Notice of Title Objection by the applicable deadline specified above, Buyer accepts the condition  
495 of title as disclosed by the Abstract of Title, Title Commitment and Title Documents as satisfactory.  
496

497 **8.3. Off-Record Title.** Seller must deliver to Buyer, on or before **Off-Record Title Deadline**, true  
498 copies of all existing surveys in Seller's possession pertaining to the Property and must disclose to Buyer all  
499 easements, liens (including, without limitation, governmental improvements approved, but not yet installed) or  
500 other title matters not shown by public records, of which Seller has actual knowledge (Off-Record Matters).  
501 This Section excludes any **New ILC** or **New Survey** governed under § 9 (New ILC, New Survey). Buyer has  
502 the right to inspect the Property to investigate if any third party has any right in the Property not shown by  
503 public records (e.g., unrecorded easement, boundary line discrepancy or water rights). Buyer's Notice to  
504 Terminate or Notice of Title Objection of any unsatisfactory condition (whether disclosed by Seller or revealed  
505 by such inspection, notwithstanding § 8.2. (Record Title) and § 13 (Transfer of Title), in Buyer's sole  
506 subjective discretion, must be received by Seller on or before **Off-Record Title Objection Deadline**. If an  
507 Off-Record Matter is received by Buyer after the **Off-Record Title Deadline**, Buyer has until the earlier of  
508 Closing or ten days after receipt by Buyer to review and object to such Off-Record Matter. If Seller receives  
509 Buyer's Notice to Terminate or Notice of Title Objection pursuant to this § 8.3. (Off-Record Title), any title  
510 objection by Buyer is governed by the provisions set forth in § 8.7. (Right to Object to Title, Resolution). If  
511 Seller does not receive Buyer's Notice to Terminate or Notice of Title Objection by the applicable deadline  
512 specified above, Buyer accepts title subject to such Off-Record Matters and rights, if any, of third parties not  
513 shown by public records of which Buyer has actual knowledge.  
514

515 **8.4. Special Taxing Districts. SPECIAL TAXING DISTRICTS MAY BE SUBJECT TO GENERAL**  
516 **OBLIGATION INDEBTEDNESS THAT IS PAID BY REVENUES PRODUCED FROM ANNUAL TAX LEVIES**  
517 **ON THE TAXABLE PROPERTY WITHIN SUCH DISTRICTS. PROPERTY OWNERS IN SUCH DISTRICTS**  
518 **MAY BE PLACED AT RISK FOR INCREASED MILL LEVIES AND TAX TO SUPPORT THE SERVICING**  
519 **OF SUCH DEBT WHERE CIRCUMSTANCES ARISE RESULTING IN THE INABILITY OF SUCH A**  
520 **DISTRICT TO DISCHARGE SUCH INDEBTEDNESS WITHOUT SUCH AN INCREASE IN MILL LEVIES.**  
521 **BUYERS SHOULD INVESTIGATE THE SPECIAL TAXING DISTRICTS IN WHICH THE PROPERTY IS**  
522 **LOCATED BY CONTACTING THE COUNTY TREASURER, BY REVIEWING THE CERTIFICATE OF**  
523  
524

525 TAXES DUE FOR THE PROPERTY AND BY OBTAINING FURTHER INFORMATION FROM THE BOARD  
526 OF COUNTY COMMISSIONERS, THE COUNTY CLERK AND RECORDER, OR THE COUNTY  
527 ASSESSOR.

528 **8.5. Tax Certificate.** A tax certificate paid for by  Seller  Buyer, for the Property listing any  
529 special taxing districts that affect the Property (Tax Certificate) must be delivered to Buyer on or before  
530 **Record Title Deadline**. If the Property is located within a special taxing district and such inclusion is  
531 unsatisfactory to Buyer, in Buyer's sole subjective discretion, Buyer may terminate, on or before **Record Title**  
532 **Objection Deadline**. Should Buyer receive the Tax Certificate after **Record Title Deadline**, Buyer, at Buyer's  
533 option, has the Right to Terminate under § 24.1. by Buyer's Notice to Terminate received by Seller on or  
534 before ten days after Buyer's receipt of the Tax Certificate. If Buyer does not receive the Tax Certificate, or if  
535 Buyer's Notice to Terminate would otherwise be required to be received by Seller after **Closing Date**, Buyer's  
536 Notice to Terminate must be received by Seller on or before Closing. If Seller does not receive Buyer's Notice  
537 to Terminate within such time, Buyer accepts the provisions of the Tax Certificate and the inclusion of the  
538 Property in a special taxing district, if applicable, as satisfactory and Buyer waives any Right to Terminate  
539 under this provision. If Buyer's loan specified in §4.5.3. (Loan Limitations) prohibits Buyer from paying for the  
540 Tax Certificate, the Tax Certificate will be paid for by Seller.

542 **8.6. Third Party Right to Purchase/Approve.** If any third party has a right to purchase the Property  
543 (e.g., right of first refusal on the Property, right to purchase the Property under a lease or an option held by a  
544 third party to purchase the Property) or a right of a third party to approve this Contract, Seller must promptly  
545 submit this Contract according to the terms and conditions of such right. If the third-party holder of such right  
546 exercises its right this Contract will terminate. If the third party's right to purchase is waived explicitly or  
547 expires, or the Contract is approved, this Contract will remain in full force and effect. Seller must promptly  
548 notify Buyer in writing of the foregoing. If the third party right to purchase is exercised or approval of this  
549 Contract has not occurred on or before **Third Party Right to Purchase/Approve Deadline**, this Contract will  
550 then terminate. Seller will supply to Buyer, in writing, details of any Third Party Right to Purchase the  
551 Property on or before the Record Title Deadline.

553 **8.7. Right to Object to Title, Resolution.** Buyer has a right to object or terminate, in Buyer's sole  
554 subjective discretion, based on any title matters including those matters set forth in § 8.2. (Record Title), §  
555 8.3. (Off-Record Title), § 8.5. (Special Taxing District) and § 13 (Transfer of Title). If Buyer exercises Buyer's  
556 rights to object or terminate based on any such title matter, on or before the applicable deadline, Buyer has  
557 the following options:

559 **8.7.1. Title Objection, Resolution.** If Seller receives Buyer's written notice objecting to any title  
560 matter (Notice of Title Objection) on or before the applicable deadline and if Buyer and Seller have not  
561 agreed to a written settlement thereof on or before **Title Resolution Deadline**, this Contract will terminate on  
562 the expiration of **Title Resolution Deadline**, unless Seller receives Buyer's written withdrawal of Buyer's  
563 Notice of Title Objection (i.e., Buyer's written notice to waive objection to such items and waives the Right to  
564 Terminate for that reason), on or before expiration of **Title Resolution Deadline**. If either the Record Title  
565 Deadline or the Off-Record Title Deadline, or both, are extended pursuant to § 8.2. (Record Title) or § 8.3.  
566 (Off-Record Title) the Title Resolution Deadline also will be automatically extended to the earlier of Closing or  
567 fifteen days after Buyer's receipt of the applicable documents; or

569 **8.7.2. Title Objection, Right to Terminate.** Buyer may exercise the Right to Terminate under §  
570 24.1., on or before the applicable deadline, based on any title matter unsatisfactory to Buyer, in Buyer's sole  
571 subjective discretion.

572 **8.8. Title Advisory.** The Title Documents affect the title, ownership and use of the Property and  
573 should be reviewed carefully. Additionally, other matters not reflected in the Title Documents may affect the  
574 title, ownership and use of the Property, including, without limitation, boundary lines and encroachments,  
575 set-back requirements, area, zoning, building code violations, unrecorded easements and claims of  
576 easements, leases and other unrecorded agreements, water on or under the Property and various laws and  
577 governmental regulations concerning land use, development and environmental matters.

579 **8.8.1. OIL, GAS, WATER AND MINERAL DISCLOSURE. THE SURFACE ESTATE OF THE**  
580 **PROPERTY MAY BE OWNED SEPARATELY FROM THE UNDERLYING MINERAL ESTATE AND**  
581 **TRANSFER OF THE SURFACE ESTATE MAY NOT NECESSARILY INCLUDE TRANSFER OF THE**  
582 **MINERAL ESTATE OR WATER RIGHTS. THIRD PARTIES MAY OWN OR LEASE INTERESTS IN OIL,**

583 GAS, OTHER MINERALS, GEOTHERMAL ENERGY OR WATER ON OR UNDER THE SURFACE OF THE  
584 PROPERTY, WHICH INTERESTS MAY GIVE THEM RIGHTS TO ENTER AND USE THE SURFACE OF  
585 THE PROPERTY TO ACCESS THE MINERAL ESTATE, OIL, GAS OR WATER.

586 8.8.2. SURFACE USE AGREEMENT. THE USE OF THE SURFACE ESTATE OF THE  
587 PROPERTY TO ACCESS THE OIL, GAS OR MINERALS MAY BE GOVERNED BY A SURFACE USE  
588 AGREEMENT, A MEMORANDUM OR OTHER NOTICE OF WHICH MAY BE RECORDED WITH THE  
589 COUNTY CLERK AND RECORDER.

591 8.8.3. OIL AND GAS ACTIVITY. OIL AND GAS ACTIVITY THAT MAY OCCUR ON OR  
592 ADJACENT TO THE PROPERTY MAY INCLUDE, BUT IS NOT LIMITED TO, SURVEYING, DRILLING,  
593 WELL COMPLETION OPERATIONS, STORAGE, OIL AND GAS, OR PRODUCTION FACILITIES,  
594 PRODUCING WELLS, REWORKING OF CURRENT WELLS AND GAS GATHERING AND PROCESSING  
595 FACILITIES.

596 8.8.4. ADDITIONAL INFORMATION. BUYER IS ENCOURAGED TO SEEK ADDITIONAL  
597 INFORMATION REGARDING OIL AND GAS ACTIVITY ON OR ADJACENT TO THE PROPERTY,  
598 INCLUDING DRILLING PERMIT APPLICATIONS. THIS INFORMATION MAY BE AVAILABLE FROM THE  
599 COLORADO OIL AND GAS CONSERVATION COMMISSION.

601 8.8.5. Title Insurance Exclusions. Matters set forth in this Section and others, may be  
602 excepted, excluded from, or not covered by the owner's title insurance policy.

603 8.9. Mineral Rights Review. Buyer  Does  Does Not have a Right to Terminate if examination of  
604 the Mineral Rights is unsatisfactory to Buyer on or before the Mineral Rights Examination Deadline.  
605

606 9. NEW ILC, NEW SURVEY.

607 9.1. New ILC or New Survey. If the box is checked, (1)  New Improvement Location Certificate  
608 (New ILC); or, (2)  New Survey in the form of N/A; is required and the following will apply:

609 9.1.1. Ordering of New ILC or New Survey.  Seller  Buyer will order the New ILC or New  
610 Survey. The New ILC or New Survey may also be a previous ILC or survey that is in the above-required form,  
611 certified and updated as of a date after the date of this Contract.

612 9.1.2. Payment for New ILC or New Survey. The cost of the New ILC or New Survey will be paid, on  
613 or before Closing, by:  Seller  Buyer or:  
614 N/A

615 9.1.3. Delivery of New ILC or New Survey. Buyer, Seller, the issuer of the Title Commitment (or  
616 the provider of the opinion of title if an Abstract of Title) and N/A will receive a New ILC or New Survey on or  
617 before New ILC or New Survey Deadline.

618 9.1.4. Certification of New ILC or New Survey. The New ILC or New Survey will be certified by  
619 the surveyor to all those who are to receive the New ILC or New Survey.

620 9.2. Buyer's Right to Waive or Change New ILC or New Survey Selection. Buyer may select a  
621 New ILC or New Survey different than initially specified in this Contract if there is no additional cost to Seller  
622 or change to the New ILC or New Survey Objection Deadline. Buyer may, in Buyer's sole subjective  
623 discretion, waive a New ILC or New Survey if done prior to Seller incurring any cost for the same.

624 9.3. New ILC or New Survey Objection. Buyer has the right to review and object based on the New  
625 ILC or New Survey. If the New ILC or New Survey is not timely received by Buyer or is unsatisfactory to  
626 Buyer, in Buyer's sole subjective discretion, Buyer may, on or before New ILC or New Survey Objection  
627 Deadline, notwithstanding § 8.3. or § 13:

628 9.3.1. Notice to Terminate. Notify Seller in writing, pursuant to § 24.1., that this Contract is  
629 terminated; or

630 9.3.2. New ILC or New Survey Objection. Deliver to Seller a written description of any matter  
631 that was to be shown or is shown in the New ILC or New Survey that is unsatisfactory and that Buyer  
632 requires Seller to correct.

633 9.3.3. New ILC or New Survey Resolution. If a New ILC or New Survey Objection is received  
634 by Seller, on or before New ILC or New Survey Objection Deadline and if Buyer and Seller have not  
635 agreed in writing to a settlement thereof on or before New ILC or New Survey Resolution Deadline, this  
636

641 Contract will terminate on expiration of the **New ILC or New Survey Resolution Deadline**, unless Seller  
642 receives Buyer's written withdrawal of the New ILC or New Survey Objection before such termination (i.e., on  
643 or before expiration of **New ILC or New Survey Resolution Deadline**).  
644

645  
646 **DISCLOSURE, INSPECTION AND DUE DILIGENCE**  
647

648  
649 **10. PROPERTY DISCLOSURE, INSPECTION, INDEMNITY, INSURABILITY, DUE DILIGENCE AND**  
650 **SOURCE OF WATER.**

651 **10.1. Seller's Property Disclosure.** On or before **Seller's Property Disclosure Deadline**, Seller  
652 agrees to deliver to Buyer the most current version of the applicable Colorado Real Estate Commission's  
653 Seller's Property Disclosure form completed by Seller to Seller's actual knowledge and current as of the date  
654 of this Contract.  
655

656 **10.2. Disclosure of Adverse Material Facts; Subsequent Disclosure; Present Condition.** Seller  
657 must disclose to Buyer any adverse material facts actually known by Seller as of the date of this Contract.  
658 Seller agrees that disclosure of adverse material facts will be in writing. In the event Seller discovers an  
659 adverse material fact after the date of this Contract, Seller must timely disclose such adverse fact to Buyer.  
660 Buyer has the Right to Terminate based on the Seller's new disclosure on the earlier of Closing or five days  
661 after Buyer's receipt of the new disclosure. Except as otherwise provided in this Contract, Buyer  
662 acknowledges that Seller is conveying the Property to Buyer in an "**As Is**" condition, "**Where Is**" and "**With All**  
663 **Faults.**"  
664

665 **10.3. Inspection.** Unless otherwise provided in this Contract, Buyer, acting in good faith, has the right  
666 to have inspections (by one or more third parties, personally or both) of the Property, Leased Items, and  
667 Inclusions (Inspection), at Buyer's expense. If (1) the physical condition of the Property, including, but not  
668 limited to, the roof, walls, structural integrity of the Property, the electrical, plumbing, HVAC and other  
669 mechanical systems of the Property, (2) the physical condition of the Inclusions and Leased Items, (3) service  
670 to the Property (including utilities and communication services), systems and components of the Property  
671 (e.g., heating and plumbing), (4) any proposed or existing transportation project, road, street or highway, or  
672 (5) any other activity, odor or noise (whether on or off the Property) and its effect or expected effect on the  
673 Property or its occupants is unsatisfactory, in Buyer's sole subjective discretion, Buyer may:  
674

675 **10.3.1. Inspection Termination.** On or before the **Inspection Termination Deadline**, notify  
676 Seller in writing, pursuant to § 24.1., that this Contract is terminated due to any unsatisfactory condition,  
677 provided the Buyer did not previously deliver an Inspection Objection. Buyer's Right to Terminate under this  
678 provision expires upon delivery of an Inspection Objection to Seller pursuant to § 10.3.2.; or

679 **10.3.2. Inspection Objection.** On or before the **Inspection Objection Deadline**, deliver to  
680 Seller a written description of any unsatisfactory condition that Buyer requires Seller to correct.

681 **10.3.3. Inspection Resolution.** If an Inspection Objection is received by Seller, on or before  
682 **Inspection Objection Deadline** and if Buyer and Seller have not agreed in writing to a settlement thereof on  
683 or before **Inspection Resolution Deadline**, this Contract will terminate on **Inspection Resolution Deadline**  
684 unless Seller receives Buyer's written withdrawal of the Inspection Objection before such termination (i.e., on  
685 or before expiration of **Inspection Resolution Deadline**). Nothing in this provision prohibits the Buyer and  
686 the Seller from mutually terminating this Contract before the Inspection Resolution Deadline passes by  
687 executing an Earnest Money Release.  
688

689 **10.4. Damage, Liens and Indemnity.** Buyer, except as otherwise provided in this Contract or other  
690 written agreement between the parties, is responsible for payment for all inspections, tests, surveys,  
691 engineering reports, or other reports performed at Buyer's request (Work) and must pay for any damage that  
692 occurs to the Property and Inclusions as a result of such Work. Buyer must not permit claims or liens of any  
693 kind against the Property for Work performed on the Property. Buyer agrees to indemnify, protect and hold  
694 Seller harmless from and against any liability, damage, cost or expense incurred by Seller and caused by any  
695 such Work, claim, or lien. This indemnity includes Seller's right to recover all costs and expenses incurred by  
696 Seller to defend against any such liability, damage, cost or expense, or to enforce this Section, including  
697 Seller's reasonable attorney fees, legal fees and expenses. The provisions of this Section survive the

700 termination of this Contract. This § 10.4. does not apply to items performed pursuant to an Inspection  
701 Resolution.

702 **10.5. Insurability.** Buyer has the Right to Terminate under § 24.1., on or before **Property Insurance**  
703 **Termination Deadline**, based on any unsatisfactory provision of the availability, terms and conditions and  
704 premium for property insurance (Property Insurance) on the Property, in Buyer's sole subjective discretion.

705 **10.6. Due Diligence.**

706 **10.6.1. Due Diligence Documents.** Seller agrees to deliver copies of the following documents

737  **10.6.1.4.8.** All insurance policies pertaining to the Property and copies of any claims  
738 which have been made for the past years;

739  **10.6.1.4.9.** Soils reports, surveys and engineering reports or data pertaining to the  
740 Property (if not delivered earlier under § 8.3.);

741  **10.6.1.4.10.** Any and all existing documentation and reports regarding Phase I and II  
742 environmental reports, letters, test results, advisories and similar documents respective to the existence or  
743 nonexistence of asbestos, PCB transformers, or other toxic, hazardous or contaminated substances and/or  
744 underground storage tanks and/or radon gas. If no reports are in Seller's possession or known to Seller,  
745 Seller warrants that no such reports are in Seller's possession or known to Seller;

746  **10.6.1.4.11.** Any *Americans with Disabilities Act* reports, studies or surveys concerning  
747 the compliance of the Property with said Act;

748  **10.6.1.4.12.** All permits, licenses and other building or use authorizations issued by any  
749 governmental authority with jurisdiction over the Property and written notice of any violation of any such

759  10.6.1.4.13. Other:

761 **10.6.2. Due Diligence Documents Review and Objection.** Buyer has the right to review and  
762 object based on the Due Diligence Documents. If the Due Diligence Documents are not supplied to Buyer or  
763 are unsatisfactory, in Buyer's sole subjective discretion, Buyer may, on or before **Due Diligence Documents**  
764 **Objection Deadline:**

766 **10.6.2.1. Notice to Terminate.** Notify Seller in writing, pursuant to § 24.1., that this Contract  
767 is terminated; or

768 **10.6.2.2. Due Diligence Documents Objection.** Deliver to Seller a written description of  
769 any unsatisfactory Due Diligence Documents that Buyer requires Seller to correct.

770 **10.6.2.3. Due Diligence Documents Resolution.** If a Due Diligence Documents Objection

781 **10.6.4. Due Diligence – Environmental, ADA.** Buyer has the right to obtain environmental

800 Buyer has the Right to Terminate under § 24.1., on or before **ADA Evaluation Termination Deadline**,  
801 based on any unsatisfactory ADA Evaluation, in Buyer's sole subjective discretion.

802 **10.7. Conditional Upon Sale of Property.** This Contract is conditional upon the sale and closing of  
803 that certain property owned by Buyer and commonly known as N/A. Buyer has the Right to Terminate under  
804 § 24.1. effective upon Seller's receipt of Buyer's Notice to Terminate on or before **Conditional Sale Deadline**  
805 if such property is not sold and closed by such deadline. This Section is for the sole benefit of Buyer. If Seller  
806 does not receive Buyer's Notice to Terminate on or before **Conditional Sale Deadline**, Buyer waives any  
807 Right to Terminate under this provision.

809 **10.8. Source of Potable Water (Residential Land and Residential Improvements Only).** Buyer  
810  Does  Does Not acknowledge receipt of a copy of Seller's Property Disclosure or Source of Water

840 **11.1.2.** That said Lease is in full force and effect and that there have been no subsequent  
841 modifications or amendments;

843 Seller;

844 **11.1.4.** The amount of monthly (or other applicable period) rental paid to Seller;

845 **11.1.5.** That there is no default under the terms of said Lease by landlord or occupant; and

846 **11.1.6.** That the Lease to which the Estoppel Statement is attached is a true, correct and  
847 complete copy of the Lease demising the premises it describes.  
848

849 **11.2. Seller Estoppel Statement.** In the event Seller does not receive from all tenants of the Property  
850 a completed signed Estoppel Statement, Seller agrees to complete and execute an Estoppel Statement  
851 setting forth the information and documents required §11.1. above and deliver the same to Buyer on or  
852 before **Estoppel Statements Deadline**.  
853

854 **11.3. Estoppel Statements Termination.** Buyer has the Right to Terminate under § 24.1., on or  
855 before **Estoppel Statements Termination Deadline**, based on any unsatisfactory Estoppel Statement, in  
856 Buyer's sole subjective discretion, or if Seller fails to deliver the Estoppel Statements on or before **Estoppel**  
857 **Statements Deadline**. Buyer also has the unilateral right to waive any unsatisfactory Estoppel Statement.

863 **12. CLOSING DOCUMENTS, INSTRUCTIONS AND CLOSING.**

864 **12.1. Closing Documents and Closing Information.** Seller and Buyer will cooperate with the  
865 Closing Company to enable the Closing Company to prepare and deliver documents required for Closing to  
866 Buyer and Seller and their designees. If Buyer is obtaining a loan to purchase the Property, Buyer

879 **12.4. Disclosure of Settlement Costs.** Buyer and Seller acknowledge that costs, quality and extent

882 **12.5. Assignment of Leases.** Seller must assign to Buyer all Leases at Closing that will continue  
883 after Closing and Buyer must assume Seller's obligations under such Leases. Further, Seller must transfer to  
884 Buyer all Leased Items and assign to Buyer such leases for the Leased Items accepted by Buyer pursuant to  
885 § 2.5.4. (Leased Items).

888 **13. TRANSFER OF TITLE.** Subject to Buyer's compliance with the terms and provisions of this Contract,  
889 including the tender of any payment due at Closing, Seller must execute and deliver the following good and

891  bargain and sale deed  quit claim deed  personal representative's deed  N/A deed. Seller, provided  
892 another deed is not selected, must execute and deliver a good and sufficient special warranty deed to Buyer,

896 warranty deed or a general warranty deed, title will be conveyed "subject to statutory exceptions" as defined

899 **14. PAYMENT OF LIENS AND ENCUMBRANCES.** Unless agreed to by Buyer in writing, any amounts  
900 owed on any liens or encumbrances securing a monetary sum against the Property and Inclusions, including  
901 any governmental liens for special improvements installed as of the date of Buyer's signature hereon,  
902 whether assessed or not, and previous years' taxes, will be paid at or before Closing by Seller from the  
903 proceeds of this transaction or from any other source.

922  One-Half by Buyer and One-Half by Seller  N/A.

923 **15.3.4. Other Fees.** Any other fee listed in the Status Letter as required to be paid at Closing will  
924 be paid by  Buyer  Seller  One-Half by Buyer and One-Half by Seller  N/A.

925 **15.4. Local Transfer Tax.** Any Local Transfer Tax must be paid at Closing by  Buyer  Seller  
926  One-Half by Buyer and One-Half by Seller  N/A.

927 **15.5. Sales and Use Tax.** Any sales and use tax that may accrue because of this transaction must be  
928 paid when due by  Buyer  Seller  One-Half by Buyer and One-Half by Seller  N/A.

933 **15.6. Private Transfer Fee.** Any private transfer fees and other fees due to a transfer of the Property,  
934 payable at Closing, such as community association fees, developer fees and foundation fees, must be paid at  
935 Closing by  Buyer  Seller  One-Half by Buyer and One-Half by Seller  N/A.

936 **15.7. Water Transfer Fees.** Water Transfer Fees can change. The fees, as of the date of this

944 **15.9.1. FIRPTA.** The Internal Revenue Service (IRS) may require a substantial portion of the  
945 Seller's proceeds be withheld after Closing when Seller is a foreign person. If required withholding does not  
946 occur, the Buyer could be held liable for the amount of the Seller's tax, interest and penalties. If the box in  
947 this Section is checked, Seller represents that Seller  IS a foreign person for purposes of U.S. income  
948 taxation. If the box in this Section is not checked, Seller represents that Seller is not a foreign person for

**17. POSSESSION.** Possession of the Property and Inclusions will be delivered to Buyer on **Possession Date** at **Possession Time**, subject to the Leases as set forth in § 10.6.1.1.

If Seller, after Closing occurs, fails to deliver possession as specified, Seller will be subject to eviction and will be additionally liable to Buyer, notwithstanding § 20.2. (If Seller is in Default), for payment of \$ *n/a* per day (or any part of a day notwithstanding § 3.3., Day) from **Possession Date** and **Possession Time** until possession is delivered.

## General Provisions

**18. CAUSES OF LOSS, INSURANCE; DAMAGE TO INCLUSIONS AND SERVICES; CONDEMNATION; AND WALK-THROUGH.** Except as otherwise provided in this Contract, the Property, Inclusions or both will be delivered in the condition existing as of the date of this Contract, ordinary wear and tear excepted.

**18.1. Causes of Loss, Insurance.** In the event the Property or Inclusions are damaged by fire, other perils or causes of loss prior to Closing (Property Damage) in an amount of not more than ten percent of the total Purchase Price and if the repair of the damage will be paid by insurance (other than the deductible to be paid by Seller), then Seller, upon receipt of the insurance proceeds, will use Seller's reasonable efforts to repair the Property before **Closing Date**. Buyer has the Right to Terminate under § 24.1., on or before **Closing Date**, if the Property is not repaired before **Closing Date**, or if the damage exceeds such sum. Should Buyer elect to carry out this Contract despite such Property Damage, Buyer is entitled to a credit at Closing for all insurance proceeds that were received by Seller (but not the Association, if any) resulting from damage to the Property and Inclusions, plus the amount of any deductible provided for in the insurance policy. This credit may not exceed the Purchase Price. In the event Seller has not received the insurance proceeds prior to Closing, the parties may agree to extend the **Closing Date** to have the Property repaired prior to Closing or, at the option of Buyer, (1) Seller must assign to Buyer the right to the proceeds at Closing, if acceptable to Seller's insurance company and Buyer's lender; or (2) the parties may enter into a written agreement prepared by the parties or their attorney requiring the Seller to escrow at Closing from Seller's sale proceeds the amount Seller has received and will receive due to such damage, not exceeding the total Purchase Price, plus the amount of any deductible that applies to the insurance claim.

**18.2. Damage, Inclusions and Services.** Should any Inclusion or service (including utilities and communication services), system, component or fixture of the Property (collectively Service) (e.g., heating or plumbing), fail or be damaged between the date of this Contract and Closing or possession, whichever is earlier, then Seller is liable for the repair or replacement of such Inclusion or Service with a unit of similar size, age and quality, or an equivalent credit, but only to the extent that the maintenance or replacement of such Inclusion or Service is not the responsibility of the Association, if any, less any insurance proceeds received by Buyer covering such repair or replacement. If the failed or damaged Inclusion or Service is not repaired or replaced on or before Closing or possession, whichever is earlier, Buyer has the Right to Terminate under § 24.1., on or before **Closing Date**, or, at the option of Buyer, Buyer is entitled to a credit at Closing for the repair or replacement of such Inclusion or Service. Such credit must not exceed the Purchase Price. If Buyer receives such a credit, Seller's right for any claim against the Association, if any, will survive Closing.

**18.3. Condemnation.** In the event Seller receives actual notice prior to Closing that a pending condemnation action may result in a taking of all or part of the Property or Inclusions, Seller must promptly notify Buyer, in writing, of such condemnation action. Buyer has the Right to Terminate under § 24.1., on or before **Closing Date**, based on such condemnation action, in Buyer's sole subjective discretion. Should Buyer elect to consummate this Contract despite such diminution of value to the Property and Inclusions, Buyer is entitled to a credit at Closing for all condemnation proceeds awarded to Seller for the diminution in the value of the Property or Inclusions, but such credit will not include relocation benefits or expenses or exceed the Purchase Price.

**18.4. Walk-Through and Verification of Condition.** Buyer, upon reasonable notice, has the right to walk through the Property prior to Closing to verify that the physical condition of the Property and Inclusions

1051 **18.5. Home Warranty. [Intentionally Deleted]**

1052 **18.6. Risk of Loss – Growing Crops.** The risk of loss for damage to growing crops by fire or other  
1053 casualty will be borne by the party entitled to the growing crops as provided in § 2.8. and such party is  
1054 entitled to such insurance proceeds or benefits for the growing crops.  
1055

1056 **19. RECOMMENDATION OF LEGAL AND TAX COUNSEL.** By signing this Contract, Buyer and Seller  
1057 acknowledge that their respective broker has advised that this Contract has important legal consequences  
1058 and has recommended: (1) legal examination of title; (2) consultation with legal and tax or other counsel  
1059 before signing this Contract as this Contract may have important legal and tax implications; (3) to consult with  
1060 their own attorney if Water Rights, Mineral Rights or Leased Items are included or excluded in the sale; and  
1061 (4) to consult with legal counsel if there are other matters in this transaction for which legal counsel should be  
1062 engaged and consulted. Such consultations must be done timely as this Contract has strict time limits,  
1063 including deadlines, that must be complied with.  
1064

1065 **20. TIME OF ESSENCE, DEFAULT AND REMEDIES.** Time is of the essence for all dates and deadlines  
1066 in this Contract. This means that all dates and deadlines are strict and absolute. If any payment due,  
1067 including Earnest Money, is not paid, honored or tendered when due, or if any obligation is not performed  
1068 timely as provided in this Contract or waived, the non-defaulting party has the following remedies:  
1069

1070 **20.1. If Buyer is in Default:**

1071  **20.1.1. Specific Performance.** Seller may elect to cancel this Contract and all Earnest Money  
1072 (whether or not paid by Buyer) will be paid to Seller and retained by Seller. It is agreed that the Earnest  
1073 Money is not a penalty, and the parties agree the amount is fair and reasonable. Seller may recover such  
1074 additional damages as may be proper. Alternatively, Seller may elect to treat this Contract as being in full  
1075 force and effect and Seller has the right to specific performance or damages, or both.

1077 **20.1.2. Liquidated Damages, Applicable. This § 20.1.2. applies unless the box in § 20.1.1. is**  
1078 **checked.** Seller may cancel this Contract. All Earnest Money (whether or not paid by Buyer) will be paid to  
1079 Seller and retained by Seller. It is agreed that the Earnest Money amount specified in § 4.1. is LIQUIDATED  
1080 DAMAGES and not a penalty, which amount the parties agree is fair and reasonable and (except as provided  
1081 in §§ 10.4. and 21), such amount is SELLER'S ONLY REMEDY for Buyer's failure to perform the obligations  
1082 of this Contract. Seller expressly waives the remedies of specific performance and additional damages.  
1083

1084 **20.2. If Seller is in Default:**

1085 **20.2.1. Specific Performance, Damages or Both.** Buyer may elect to treat this Contract as  
1086 canceled, in which case all Earnest Money received hereunder will be returned to Buyer and Buyer may  
1087 recover such damages as may be proper. Alternatively, in addition to the per diem in § 17 (Possession) for  
1088 failure of Seller to timely deliver possession of the Property after Closing occurs, Buyer may elect to treat this  
1089 Contract as being in full force and effect and Buyer has the right to specific performance or damages, or  
1090 both.  
1091

1092 **20.2.2. Seller's Failure to Perform.** In the event Seller fails to perform Seller's obligations under  
1093 this Contract, to include, but not limited to, failure to timely disclose Association violations known by Seller,  
1094 failure to perform any replacements or repairs required under this Contract or failure to timely disclose any  
1095 known adverse material facts, Seller remains liable for any such failures to perform under this Contract after  
1096 Closing. Buyer's rights to pursue the Seller for Seller's failure to perform under this Contract are reserved and  
1097 survive Closing.  
1098

1099 **21. LEGAL FEES, COST AND EXPENSES.** Anything to the contrary herein notwithstanding, in the event  
1100 of any arbitration or litigation relating to this Contract, prior to or after **Closing Date**, the arbitrator or court  
1101 must award to the prevailing party all reasonable costs and expenses, including attorney fees, legal fees and  
1102 expenses.  
1103

1104 **22. MEDIATION.** If a dispute arises relating to this Contract (whether prior to or after Closing) and is not  
1105 resolved, the parties must first proceed, in good faith, to mediation. Mediation is a process in which the  
1106  
1107

1108 parties meet with an impartial person who helps to resolve the dispute informally and confidentially. Mediators  
1109 cannot impose binding decisions. Before any mediated settlement is binding, the parties to the dispute must  
1110 agree to the settlement, in writing. The parties will jointly appoint an acceptable mediator and will share  
1111 equally in the cost of such mediation. The obligation to mediate, unless otherwise agreed, will terminate if the  
1112 entire dispute is not resolved within thirty days of the date written notice requesting mediation is delivered by  
1113 one party to the other at that party's last known address (physical or electronic as provided in § 26). Nothing  
1114 in this Section prohibits either party from filing a lawsuit and recording a *lis pendens* affecting the Property,  
1115 before or after the date of written notice requesting mediation. This Section will not alter any date in this  
1116 Contract, unless otherwise agreed.  
1117

1118  
1119 **23. EARNEST MONEY DISPUTE.** Except as otherwise provided herein, Earnest Money Holder must  
1120 release the Earnest Money following receipt of written mutual instructions, signed by both Buyer and Seller.  
1121 In the event of any controversy regarding the Earnest Money, Earnest Money Holder is not required to  
1122 release the Earnest Money. Earnest Money Holder, in its sole subjective discretion, has several options: (1)  
1123 wait for any proceeding between Buyer and Seller; (2) interplead all parties and deposit Earnest Money into a  
1124 court of competent jurisdiction (Earnest Money Holder is entitled to recover court costs and reasonable  
1125 attorney and legal fees incurred with such action); or (3) provide notice to Buyer and Seller that unless  
1126 Earnest Money Holder receives a copy of the Summons and Complaint or Claim (between Buyer and Seller)  
1127 containing the case number of the lawsuit (Lawsuit) within one hundred twenty days of Earnest Money

1135 **24.1. Right to Terminate.** If a party has a right to terminate, as provided in this Contract (Right to  
1136 Terminate), the termination is effective upon the other party's receipt of a written notice to terminate (Notice to  
1137 Terminate), provided such written notice was received on or before the applicable deadline specified in this  
1138 Contract. If the Notice to Terminate is not received on or before the specified deadline, the party with the  
1139 Right to Terminate accepts the specified matter, document or condition as satisfactory and waives the Right  
1140 to Terminate under such provision.

1142 **24.2. Effect of Termination.** In the event this Contract is terminated, and all Earnest Money received  
1143 hereunder is timely returned to Buyer, the parties are relieved of all obligations hereunder, subject to §§ 10.4.

1147 **25. ENTIRE AGREEMENT, MODIFICATION, SURVIVAL; SUCCESSORS.** This Contract, its exhibits and  
1148 specified addenda, constitute the entire agreement between the parties relating to the subject hereof and any  
1149 prior agreements pertaining thereto, whether oral or written, have been merged and integrated into this  
1150 Contract. No subsequent modification of any of the terms of this Contract is valid, binding upon the parties, or  
1151 enforceable unless made in writing and signed by the parties. Any right or obligation in this Contract that, by  
1152 its terms, exists or is intended to be performed after termination or Closing survives the same. Any successor  
1153 to a party receives the predecessor's benefits and obligations of this Contract.
